Key Note Speaker

Kathryn Millichamp

After a brief stint of 7 years as a General Practice Nurse, Kathryn has spent the past 22 years employed by the Auckland District Health Board. in the Ophthalmology Department. For 13 vears she worked predominantly as a Clinical Nurse Specialist; becoming Nurse Practitioner in Ophthalmology in September 2018. Her role involves assessment and management of patients with acute ophthalmic conditions, performing incision and

Hayley M Hall


ANUM, Palliative Care Ward, Austin Health


