## APPENDIX A: CONSTITUTIONAL CHANGES

## 13. COMPOSITION AND MEMBERSHIP OF COMMITTEE

Change it:
From:
The committee is to consist of:
(a) The office-bearers of the association, and
(b) At least 3 ordinary committee members,

Each of whom is to be elected at the annual general meeting of the association under clause 15.

Note. Section 28 of the Act contains further requirements concerning eligibility for membership and composition of the committee.

The total number of committee members is a minimum of 3 .
The office-bearers of the association are as follows:

- Chair (termed as President),
- Vice-president,
- Treasurer,
- Secretary.
- Committee members

A committee member may hold up to 2 offices
There is no maximum number of consecutive terms for which a committee member may hold office.
Each member of the committee is, subject to this constitution, to hold office until immediately before the election of committee members at the annual general meeting next following the date of the member's election, and is eligible for reelection.

Additional committee members, above the minimum 3 may be added to the Committee to meet the growth, administrative and project activities of the association (e.g. Vice-President, Media, and Education Managers)

To:
The Committee is to consist of:
(a) The Core office-bearers of the association:
a. chair (termed president)
b. treasurer
c. secretary

Each of whom is to be elected at the annual general meeting of the association under clause 15.
Note. Section 28 of the Act contains further requirements concerning eligibility for membership and composition of the committee.

The core office-bearers may be joined by other committee members, elected at the annual general meeting of the association under clause 15.

Other committee member positions and duties may be determined at each annual general meeting, to reflect the commitment levels of the voluntary nominating members, and the growth, administrative, project activity and direction of the association at that point in time (e.g. vice-president, media representative, state representative, education manager, general committee member and so on).

A committee member may hold up to 2 offices at a time.
There is no maximum number of consecutive terms for which a committee member may hold office.

Each member of the Committee is subject to this constitution, to hold office until immediately before the election of committee members at the annual general meeting next following the date of the member's election and is eligible for re-election.

## 39 FINANCIAL YEAR

The financial year of the association is each period of 12 months after the expiration of the previous financial year of the association, commencing on $1^{\text {st }}$ March and ending on the following February.

The financial year of the association is a period of 12 months, commencing $1^{\text {st }}$ July and ending on June $30^{\text {th }}$.
